With a strong focus on stakeholder engagement, the role will work in collaboration with ACT Schools, Aussie Hoops Centres and the greater ACT community to drive increased participation and customer engagement through the development and implementation Basketball ACT programs.

<b>Organisational Background &amp; Context</b>	<p>Basketball ACT is recognised by Basketball Australia and the ACT Government as the governing body for the sport of basketball in the ACT, and conducts competitions, development and performance programs throughout the region.</p> <p>Basketball ACT has approximately 8,000 registered participants each year, ranging from 5 to 70 years of age and involved in competitions, introductory and development programs. With over 600 teams, Basketball ACT is one of the largest basketball associations in Australia and has over two hundred referees and officials.</p> <p>Basketball ACT owns and operates its own four indoor court facility at 42 Oatley Court Belconnen ACT.</p> <p>Basketball ACT is a community, member based, organisation and works closely with school and community clubs in the delivery of basketball.</p>
